Bulgaria Labor Laws And Regulations

According to Art. 326(2) of the Labour Code, the notice period varies depending on whether the working contract is permanent and temporary. In case of a permanent contract, the law in Bulgaria provides for a notice period of 30 days, as long as the

parties have not previously agreed on a longer period (that shall not exceed 3 months).

Employment of foreign persons: All foreign persons that have a permanent residence permit or are granted the right of sanctuary or refugee status can be employed in the same way as Bulgarian citizens. Temporary work permits are issued by the National Office of Employment of the Ministry of Labour and Social Policy.

Laws applicable to foreign nationals Non-EU nationals (foreign nationals) employed by a Bulgarian employer are subject to the Bulgarian labor law (BgLL), unless a specific Bulgarian law or applicable international treaty provides otherwise. If the work is performed in Bulgaria, the BgLL always applies if it is more favorable for the employees.
