Wilde was the one to initiate the first trial, charging Queensberry with criminal libel. For a while, the trial went well for Wilde. There was no question that Queensberry had done what Wilde had claimed; the point of contention was whether Queensberry's claims were true. If they were, it wasn't libel.

### The Trials of Oscar Wilde — Making Queer History

The Marquess was the father of Wilde's lover, Lord Alfred Douglas. The libel trial unearthed evidence that caused Wilde to drop his charges and led to his own arrest and trial for gross indecencywith men. After two more trials he was convicted and sentenced to two years' hard labour, the maximum penalty, and was jailed from 1895 to 1897.
